

## Alaskan Malamute Club of America, Inc. Top Twenty Committee Suzanne Bedell, Committee Chair

On behalf of AMCA's Top Twenty Committee we wish to thank you for offering your services as a POTENTIAL BREEDER JUDGE at our upcoming event. This event will be held **Thursday** 

**evening, October 31, 2019 at the Capitol Plaza Hotel in Topeka, KS.** In order to protect the integrity of this event the following RESTRICTIONS and QUALIFICATONS need to be verified before your name can be placed on the polling ballot.

In accordance with the Top Twenty Rules the following RESTRICTIONS apply to every judge on the panel.

**Judging Restrictions:** To protect the integrity of the competition, a listing of Judging Restrictions has been established which apply to ALL JUDGES being considered for an assignment.

- 1. Cannot judge an AMCA Top Twenty Event within a period of SEVEN YEARS; judges may become eligible in the 8th year following their previous assignment.
- 2. Cannot have any connection to any dog/bitch in the Top 20 Final Standings for the year this event is being held. These connections are identified as:
  - a. Cannot own or co-own any dog/bitch eligible for entry in the competition.
  - b. Cannot own or co-own the sire or dam of any dog/bitch for entry in the competition.
  - c. Cannot have bred or co-bred a bitch to any dog eligible for entry in the competition.
  - d. Cannot have bred or co-bred a dog to any bitch eligible for entry in the competition.
  - e. Cannot own or co-own any puppies produced by a dog/bitch eligible for entry in the competition.
  - f. Cannot share National week accommodations with the breeder, owner, co-owner or handler of any dog/bitch eligible for entry in the competition.
  - g. Cannot co-own any dogs with any owner or co-owner of a Top 20 qualified dog/bitch

Additional QUALIFICATION CRITERIA & RESTRICTIONS apply to the BREEDER JUDGE category.

#### **Qualification Criteria**

- 1. Be an established Alaskan Malamute breeder for a minimum period of five (5) years.
- 2. Members that reside in the United States must have produced at least five (5) Alaskan Malamute AKC conformation champions.
- 3. Members that reside in Canada or At Large must have produced at least five (5) Alaskan Malamute conformation champions in their country of domicile.
- 4. Must return a completed and signed "Breeder Judges Contract" acknowledging that he/she meets the requisite criteria stated in the Top 20 Rules.

#### Restrictions

- Two or more AMCA members of the same household may be nominated; however, the first name selected and approved from the member household shall result in the disqualification of the other member(s) from the same household.
- 2. Only one Canadian or At-Large member will be allowed per judging panel.

### In addition if the BREEDER JUDGE is also an AKC Licensed Judge the following Restriction applies.

Conformation judges who are under contract for future AMCA National Specialties and associated Regional Specialties shall not be eligible to judge any Top Twenty Event prior to and including the year of their assignment. Past National and associated Regional Specialty conformation judges shall not be eligible to judge any Top Twenty Event for a period of seven (7) years after their assignment.

If you feel that you meet ALL of above qualifications and are not disqualified by ANY of the RESTRICTIONS you are invited to be considered as a potential judge at this event.

All potential judges that return the attached BREEDER JUDGE STATEMENT & CONTRACT will be included on the polling ballot which will be provided to the Top Twenty Participants. Judges are selected by <u>random draw</u> from the ballots submitted by the entrants.

In order to complete the process, you MUST COMPLETE, SIGN and RETURN the attached "Breeder Judge Statement & Contract" by Thursday, August 1, 2019. Contract should be sent to:
